#### ENVIRONMENTAL ACTION STATEMENT

Within the spirit and intent of the Council of Environmental Quality's regulations for implementing the National Environmental Policy Act (NEPA) and other statutes, orders and policies that protect fish and wildlife resources, I have established the following administrative record and have determined that the action of the Final Amendment to the Housatonic River Basin Final Natural Resources Restoration Plan, Environmental Assessment, and Environmental Impact Evaluation for Connecticut:

is a categorical exclusion as provided by 516 DM 6 Appendix 1 and 516 DM 6, Appendix 1. No further documentation will therefore be made.

#### FINDING OF NO SIGNIFICANT IMPACT

Final Amendment to the Housatonic River Basin Final Natural Resources Restoration Plan, Environmental Assessment, and Environmental Impact Evaluation for Connecticut

The U.S. Department of the Interior, National Oceanic and Atmospheric Administration, and State of Connecticut have completed a Final Amendment that identifies and evaluates eleven alternatives to restore aquatic resources impacted by polychlorinated biphenyls from the General Electric facility in Pittsfield, Massachusetts. The preferred alternative is to implement the following seven projects to benefit aquatic natural resources:

- Power Line Marsh Tidal Wetlands Restoration Milford, CT (\$55,000)
- Long Beach West Salt Marsh Restoration and Habitat Enhancement Stratford, CT (\$40,000)
- Pin Shop Pond Dam Removal Steele Brook (Naugatuck River Watershed), Watertown, CT (\$700.000)
- Old Papermill Pond Dam Removal Feasibility Study (East Aspetuck River Watershed), New Milford, CT (\$100,000)
- Housatonic Watershed Continuity Project (\$150,000)
- Tingue Dam Fish Passage Naugatuck River Seymour, CT (\$672,000)
- McKinney NWR Salt Marsh Restoration Stratford, CT (\$300,000)

By implementing these projects, the Trustees seek to increase the restoration of injured aquatic natural resources and more fully compensate the public for the full suite of injuries to the environment resulting from the release of hazardous substances from the GE facility in Pittsfield, Massachusetts, thereby fulfilling the goals of the original Restoration Plan. Four other alternatives (no action, Leete's Island restoration, Heminway Pond Dam Removal, and an Eel Research and Passage Feasibility Project) were evaluated and determined to be not preferred.

The Trustees provided the Draft Amendment for public review from February 8, 2013, through March 25, 2013. A notice of availability was published in the local media outlets, and on February 19, 2013, the Trustees held a public meeting to discuss the Draft Amendment and to respond to questions from the public. Trustee responses to public comments and questions are presented in Section 6 of the Final Amendment.

Based on a review and evaluation of the information contained in the Final Amendment, I have determined that the proposed actions do not constitute a major federal action which would significantly affect the quality of the human environment within the meaning of Section 102 (2)(c) of the National Environmental Policy Act of 1969. Accordingly, the preparation of an environmental impact statement on the proposed actions is not required at this time.
