## Onondaga Lake Natural Resource Damage Assessment

As a result of decades of industrial and other activity, Onondaga Lake in NY, its tributaries, and the natural resources that utilize these habitats, likely have been injured by hazardous substances. While the NYS Department of **Environmental Conservation** (NYSDEC) continues to oversee clean-up efforts, the natural resource trustees for this site – the US Fish and Wildlife Service. NYSDEC, and the Onondaga Nation – are conducting a Natural Resource Damage Assessment (NRDA) process to assess injury and restore injured natural resources.

Money recovered through the NRDA process will be used to fund projects that restore, replace, or acquire the equivalent of injured natural resources or compensate the public for lost services provided by those resources. The Trustees are requesting ideas for such projects. Suggestions will be evaluated using regulatory and site specific criteria. This Fact Sheet describes Trustee restoration goals, project criteria, and the public participation process.

# **Restoration**

Trustee Goals, Criteria, and Public Process



#### **Restoration Goals**

Eligible projects must benefit natural resources and resource services damaged or lost due to contamination. Resources include animals that live in or use stream, shoreline and/or lake habitat within the Onondaga Lake watershed. Resource services include ecological, recreational, and cultural functions.

Other restoration project criteria:

- Improves public use of/connection to relevant resources.
- Likelihood of success.
- Cost effectiveness.
- Ability to produce demonstrable, quantifiable benefits.
- Compatibility with Trustee resource management goals.
- Not funded by other sources.

### **Public Participation**
