RESOLUTION REGARDING THE RELEASE OF RESTORATION FUNDS

WHEREAS, the Trustees responsible for restoring natural resources and associated services injured, destroyed, or lost as a result of releases of hazardous substances at or from the Cornell Dubilier Electronics, Inc. Superfund Site ("Site") in South Plainfield, New Jersey, are the United States Department of Commerce, acting through the National Oceanic and Atmospheric Administration ("NOAA"), the United States Department of the Interior ("DOI"), acting through the Fish and Wildlife Service ("Service"), and the State of New Jersey, acting through the New Jersey Department of Environmental Protection ("NJDEP"), collectively ("Trustees").

WHEREAS, the Trustees entered into a Memorandum of Agreement ("MOA") by and among themselves on May 19, 2015, for the purpose of coordinating the actions of their trust responsibilities.

WHEREAS, pursuant to Paragraph XII of the MOA, natural resource damage recoveries deposited in the DOI Natural Resource Damage Assessment and Restoration ("NRDAR") interest-bearing account for the Site ("CDE DOI Account"), may be disbursed by request of all Trustees, for the purposes and objectives ascribed and authorized to the Trustees, and as described in the MOA.

WHEREAS, the Trustees have determined that funds are available and needed to implement certain restoration activities outlined in the Final Restoration Plan Environmental Assessment ("RP/EA").

WHEREAS The final RP/EA identified Tier I and Tier II projects with the expectation that Tier II projects would only be implemented if settlement monies remain after funding the higher priority Tier I projects.

WHEREAS, the Trustees have determined that excess settlement funds will be available to move forward Tier II projects since a high-cost Tier I project will be implemented through an alternative funding source.

THEREFORE, the Trustees resolve to:

1. Release a total of \$63,238.12 from the CDE DOI Account for the Site to the Service to fund the Trash Trap Installation in the Lower Raritan River Watershed project (detailed on pp. 69-71 of the RP/EA). Funds will be distributed for tasks detailed in the attached Scopes of Work by two Cooperative Agreements:

- \$39,600 will be issued to Dunellen Township to fund the following tasks:
 - i. Purchase of a Bandalong Bandit Litter Trap or equivalent ("Litter Trap"), for a location in the Green Brook at Jefferson Avenue in Dunellen, NJ;
 - ii. Freight/shipping of the Litter Trap;
 - iii. Installation costs, including fees for Stormwater Systems Bandalong technician for site installation assistance and training.

 Dunellen has agreed to maintain the Litter Trap, including emptying and disposing of collected trash from the trap, for approximately ten (10) years or the duration of its anticipated useful lifespan; including after the period of coordination with and funding for the trap provided by the Trustees.
- \$23,638.12 will be issued to the Lower Raritan Watershed Partnership to fund public outreach and monitoring associated with the Litter Trap, including the following tasks:
 - i. Design, manufacture, and installation of interpretive signage to accompany installation of the Bandalong Litter Trash Litter Trap device;
 - ii. General provision of logistical and other support to municipal partners in association with in-stream trash removal at the site of the device;
 - iii. Development of protocols and training for litter surveys;
 - iv. Development of a project database, litter survey and other data documentation, and data sharing methods with project partners and the general public;
 - v. Development and refinement of a debris management maintenance schedule for the project;
 - vi. Development and delivery of training and outreach program;
 - vii. Hosting removal demonstration and education events for public officials and Department of Public Works (DPW) staff from other municipalities and counties; and
 - viii. Project documentation.
